**ORDER**

As per the Government Order read as 1<sup>st</sup> paper above Government have accorded administrative sanction for the implementation of the upward revision of the honorarium of Anganwadi Workers and Anganwadi Helpers sanctioned by Government of India with effect from 01.04.2008.

2. As per the Government Order read as 2<sup>nd</sup> paper above Government have enhanced the rate of honorarium of Anganwadi Workers and Helpers being paid as State Share from Rs.550/- to 1000/- with effect from September 2011 and as per the Government Order read as 3<sup>rd</sup> paper above the G.O 2<sup>nd</sup> cited has been amended to give effect to the enhancement with effect from August 2011.

3. As per the letter read as 3<sup>rd</sup> paper above, Government of India have communicated their decision to enhance the honorarium of Anganwadi Workers by Rs.1500/- (Rupees One Thousand and Five Hundred only) per month and Rs.750/- (Rupees Seven Hundred and Fifty only) per month in the case of Anganwadi Helpers and Anganwadi Workers of Mini Anganwadi Centres with effect from 01-04-2011. The details of the existing rates and revised rates of Central Share are as follows:

Government have examined the matter in detail and are pleased to accord administrative sanction for the implementation of the upward revision of the honorarium of Anganwadi Workers and Anganwadi Helpers sanctioned by Government of India with effect from 01.04.2011; in the State as mentioned above incurring the expenditure from the Head of Account 2235-02-102-98-(P)-01-5-Other allowances in the current years budget subject to the condition that the enhanced honorarium does not include the additional honorarium being paid by the State Government to the Anganwadi Workers and Anganwadi Helpers.
