ORDER

As per Government Order read as 1st paper above, Smt.Radhamany.M, Programme Officer was promoted as District Social Justice Officer and posted in the District Social Justice Office Thrissur. Smt.Radhamany.M, has filed OA before the Hon'ble Kerala Administrative Tribunal praying for a direction to accommodate her in Alappuzha District since she is a native of Alappuzha District and belongs to Scheduled Caste community, she will also to retire from service on superannuation in April 2015.

2. The Hon'ble Kerala Administrative Tribunal in their final order dated 08.04.2013 read as 2nd paper above have directed the second respondent to forward Annexure A2 representation along with his comments to the first respondent within one month from the date of receipt of a copy of this order. Upon receipt of the same, the first respondent shall consider and pass orders on it, in accordance with law after affording an opportunity of being heard to the applicant within two months from the date of receipt of the same from the second respondent.

3. The Director of Social Justice as per letter read as 3rd paper above has recommended to transfer Smt.Radhamany.M, District Social Justice Officer, Thrissur to Alappuzha District vice Smt.G.Leela, District Social Justice Officer, Alappuzha considering that Smt.Radhamany.M is about to retire from service on superannuation and belongs to Scheduled Caste community. As per the direction of Hon'ble Kerala Administrative Tribunal, the Additional Secretary, Social Justice Department has heard the applicant on 17.06.2014.

4. Government after having examined the case are pleased to order that Smt.Radhamany.M, District Social Justice Officer, Thrissur and Smt.G.Leela, District Social Justice Officer, Alappuzha are mutually transferred with immediate effect.


5. The direction of the Hon'ble Kerala Administrative Tribunal in the final order read as 2 paper above is complied with accordingly.
