ORDER

As per the Government Order read as 2nd paper above, revised administrative sanction and technical sanction was accorded for the work of construction of the first phase of the Gender Park, Kozhikode excluding the electrical works (except fixing of conduits and junction boxes) based on DSR 2013, for an amount of Rs.11,86,05,354/-.The Special Officer, Gender Park, as per his letter read as 3rd paper above, has reported that he has invited e-tender for the construction of first phase of the Gender Park at Kozhikode and has informed that the Technical Sanction Committee, constituted vide Government Order read as 1st paper above, has opened the financial bid of M/s Uralungal Labour Contract Co-operative Society (ULCC), Kozhikode, who was technically qualified and the total amount quoted by M/s ULCC is Rs.17,05,28,000/- which is 43.78% higher than the amount for which Technical Sanction was received. Hence, as per the decision taken by the Tender Evaluation Committee, the Special Officer, Gender Parks has requested to place the bid received from M/s ULCC before the Tender Acceptance Committee. The Committee of Secretaries, in their meeting held on 17.03.2015, had considered the tender and has decided to recommend the bid of M/s ULCC limiting the amount for the total work as per BOQ as Rs.15,00,00,000/- which is 23.93% above the estimate as per latest SoR.

2) Government have examined the matter in detail and are pleased to accord sanction for the acceptance of tender submitted by M/s Uralungal Labour Contract Co-operative Society, Vadakara, Kozhikode for the construction of the first phase of Gender Park, Kozhikode subject to the following conditions.

- Use of Cast iron shall be substituted with Structural Steel.
- The amount for the total work is limited as per BOQ as Rs.15,00,00,000/- (Rs. Fifteen Crores only) which is 23.93% above the estimate as per latest SoR.

- No other variations shall be permitted in the original estimate other than those incidental to the substitution of cast iron with structural steel.
