#### **ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, Government have framed the Kerala State Commission for Protection of Child Rights Rules, 2012. As per the Government Order read as 2<sup>nd</sup> paper above, Shri.C.K.Viswanathan IAS (Rtd) has been appointed as the Secretary, Kerala State Commission for Protection of Child Rights.

Government are pleased to fix the following terms and conditions of appointment of Shri.C.K.Viswanathan IAS (Rtd), as the Secretary, Kerala State Commission for Protection of Child Rights.

## I Appointment:-

- (i) He shall have the rank and status of Secretary to Government.
- (ii) He shall report to the Chairperson, Kerala State Commission for Protection of Child Rights.

#### II Pay and Other Allowances:-

- (i) He shall be eligible for last pay drawn minus pension as per Rule 100 Part III KSRs.
- (ii) He shall be eligible for Dearness Allowance prescribed/revised by the Government of India from the time to time on the full basic pay last drawn.
- (iii) During the period when he draws Dearness Allowance, he shall not be entitled simultaneously to Dearness Relief on the basic pension.
- (iv) The period of re-employment will not count for any kind of pension or addition to the pension he is already drawing.

III HRA & Other Allowances:-

- (i) He shall be entitled to House Rent Allowance as applicable to an AIS Officer of equivalent rank in the Government of Kerala.
- (ii) He shall be entitled to all other allowances (including AIS Officers' Allowance) as applicable to an AIS Officer of equivalent rank in Government of Kerala.
- IV Leave, Surrender of Earned Leave, etc:-
- (i) Leave Rules shall be applicable to him as per appendix VIII, KSRs, Part I.
- (ii) Surrender of Earned leave shall be allowed in terms of G.O.(P) No. 47/2006/Fin. dated 30.01.2006.
- V <u>TA, DA:-</u>
- (i) He shall be entitled to hire car in terms of para 5 (ii) of G.O.(Ms) 72/13/GAD dated 14.03.2013.
- (ii) His eligibility for TA/DA will be as per Part II KSRs.
- VI <u>Telephone, Mobile phone & Broad Band connection:</u> Shall be payable as per the provisions in G.O.(Ms) No. 83/11/Fin dated 25.02.2011.
- VII <u>Residuary Provision:</u> He will be entitled to any benefits other than those covered above, payment will be made only after prior approval of the Government is obtained.
