**ORDER**

The Kerala State Social Welfare Board was reconstituted by Government as per the Government Order cited with eight State Government nominees and eight Central Board nominees besides the Chairperson. The State Board is implementing various social welfare programmes and activities which are formulated by the Central Social Welfare Board. For the effective implementation of these programmes, the State Government desires to nominate additional four members in the State Board with equal number of Central Social Welfare Board members. As per the letter read as 2<sup>nd</sup> paper, the Central Social Welfare Board has given in principle concurrence for inclusion of additional 8 (eight) non-official members i.e., 4 members from State Government and 4 members from the Central Social Welfare Board provided 100% (cent percent) expenditure will have to be met by the State Government.

(2) Government have examined the matter and are pleased to nominate the following four persons as State Government nominees as non-official members in the Kerala State Social Welfare Board on condition that their term shall be co-terminus with the term of the Chairperson of the State Board and the State Board shall bear all the additional expenditure for the inclusion of new eight members.
