ORDER

State Initiative on Disabilities(SID) is a scheme formulated by the State Government to provide special initiatives for persons with disabilities in the area of prevention, screening, early detection, early intervention, training, education, rehabilitation etc. Vaccination against Rubella and MMR was implemented by SID during 2013-14. About 3,00,000 MMR vaccines were administered to babies and about 5,11,000 adolescent girls studying in Std.9, 10, 11 & 12 were administered with rubella vaccines till date. Rubella vaccination has to be continued in campaign mode to adolescent girls in 8 & 9 standards for the next 11 years. As per the minutes read as 1st paper above the Empowered Committee decided to initiate steps for vaccine purchase through KMSCL after assessing the balance stock and requirement for this year, provided supply order will be placed only after approval of the SID Implementation & Monitoring Committee.

As per the minutes read as 2nd paper above, the SID Implementation & Monitoring Committee decided to release an amount of 5,76,77,815/- to KMSCL for the purchase of 6,00,000 MMR and 5,00,000 Rubella vaccines.

As per the letter read as 3rd paper above, the Project Director & Executive Director, State Initiative on Disabilities has requested Government to accord sanction to release an amount of 5,76,77,815/- to KMSCL for the purchase of 6,00,000 MMR and 5,00,000 Rubella vaccines.

Government have examined the matter in detail and are pleased to accord sanction to release an amount of 5,76,77,815/- to KMSCL for the purchase of 6,00,000 MMR and 5,00,000 Rubella vaccines from the Head of Account 2235-02-101-78(2).
