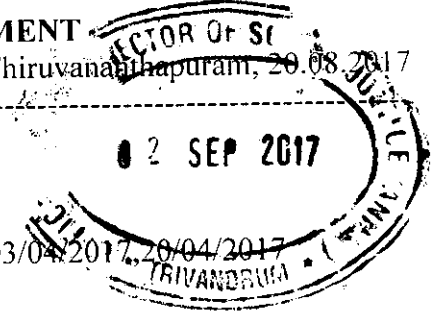

**ORDER**

The Chief Engineer, Local Self Government Department as per letter read as 4<sup>th</sup> paper above has submitted the drawal application for the reimbursement of the amount spent for the construction of building of Anganwadi as per G.O read as 2<sup>nd</sup> papers above, under RIDFXIX – 2013. The Chief Engineer has requested to release of fund under the head of account 4235-02-102-94-01 works for the 62 Anganwadies which are fully/partially completed.

2) Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs 362.87 Lakh (Rupees Three crore sixty two lakhs and eighty seven thousand only) by debit to the head of account 4235-02-102-94-01 works – Convergence of pre-school and pre primary education centres in Anganwadies – NABARD- RIDF(plan-voted) as detailed below, to the Chief Engineer, Local Self Government Department towards the claims reimbursed by NABARD for the 62 Anganwadi Projects sanction under RIDF XIX Scheme.


