Being a responsible alumni organization, we are equally anguished and saddened by the recent news of child abuse said to have occurred in the campus.

Employing the capacity of being one of the founding members of registered alumni organization of Jawahar Navodaya Vidyalaya Mayannur, Thrissur, I hereby request you Sir to provide the information listed below. The information will help the association to take an appropriate stand in the judicial case number 187/18 filed against Mr. A. Raghunandan (TGT – Music, Jawahar Navodaya Vidyalaya, Mayannur, Thrissur), by Kerala Police. The information requested comes under the jurisdiction of Child Development Project Officer – Pazhayannur, Thrissur (Dist.).

We would like to seek following information from your esteemed institution:

1. There was an incident of attempt by a staff of Jawahar Navodaya Vidyalaya, Mayannur, Thrissur to abuse his student (a minor girl child). Were you informed of this incident?

If yes, who informed you? What were the actions taken by you regarding the case?

2. Being a residential school, and especially due to this concern raised, do you think it is essential to visit the Vidyalaya to verify the security levels for children that exists in the Vidyalaya and give orientation to staff and students about child rights, its violation and the formality and procedures to handle situations like child sexual abuse?

3. Is there any plan to visit the Vidyalaya and to verify the fitness?
